N 0000 Initial Comments

At the time of the complaint investigation (GA00111951), Pur-O-Cleanse was not in compliance with Chapter 290-4-2, Rules and Regulations for Drug Abuse Treatment and Education Programs, and the following deficiencies were cited:

N 0500 290-4-2-.05 Licenses

No governing body shall operate a drug abuse treatment and education program in the state without first obtaining a license or provisional license. A licensed program may offer one or more of the program services described in these rules.

This Requirement is not met as evidenced by:

Based on observation, and review of department records, it was determined that the facility failed to operate in accordance with the State Department's guidelines for a branch (an off-site), detoxification program, of a licensed drug abuse treatment and education program. Findings Were:

Observations on 5/29/2012 at 9:20 a.m., revealed that New Life Detoxification Program at Pur-O-Cleanse located at 6487 Peachtree Industrial Blvd. Unit C, Doraville, GA 30360, was operating a drug abuse ambulatory detoxification program.

It was observed that clients from Narconon of Georgia participated in the Sauna detoxification program at this facility, which included:

- Time sweating in a Sauna;
- Taking vitamin and minerals;
- Exercise

Inspection Results

An interview on 5/29/2012 at 9:30 a.m., with the person in charge of the Sauna, stated that that New Life Detoxification Program at Pur-O-Cleanse was a detoxification program branch of Narconon of Georgia. He/She stated that Narconon of Georgia has a license that included a ambulatory detoxification program.

A review of facility documents revealed that the facility did not have a Drug Abuse Treatment and Education license for this address.

A review of client and facility records revealed that this facility did not meet the requirements of a drug abuse and education program.

A review of facility documents at Narconon of Georgia located at 5688 Peachtree Parkway, #B1, Norcross, GA, 30092. revealed that the facility had a Drug Abuse Treatment and Education license for their address which was for a outpatient and ambulatory detoxification program, New Life Detoxification Program at Pur-O-Cleanse (a branch of Narconon). This detoxification program operated Monday-Sunday, offering 8 hours of service. According to the Department's definition of "Branch", the facility should be a part time substance abuse program at a site or location different from the location of the licenses program, yet which is operated as a part of the licenses program and is not separately licensed. Therefore, Pur-O-Cleanse was operating a full time detoxification program time without a license.
